"The Council of the Cyprus Agency of Quality Assurance and Accreditation of Higher Education, during its 62 Summit on 1st and 2nd February 2021, on the basis of Article 20 (2)(f) (i) of the "Quality Assurance and Accreditation in Higher Education and the Establishment and Operation -3- of an Agency on Related Matters Laws" of 2015 to 2019 [N.136 (I)/2015 to N.35 (I)/2019], and on the basis of the suggestions of the External Evaluation Committee and the comments of the institution on the report, decided that the programme is accredited to be delivered in Greek and English and the recommendation that the Institution informs the Agency by 31/3/2021, using the form 300.1.4 Follow-up report, for the program's aim concerning vocational rehabilitation and development of graduates."

2. Institution's Response

The M.Sc. in Child and Adolescent Mental Health is a programme aimed at professionals working or wishing to work with children, adolescents and their families (e.g., medicine, psychology, nursing, social work, education, law-criminal justice). It is a non-applied degree, which offers a deepening of knowledge in areas of child and adolescent mental health with multiple applications within the exisiting fields of the applicants. It aims to prepare a specialist research-focused workforce that will help strengthen mental health care to better meet society's changing demographic health needs through new innovative and creative working practices. This programme of study offers a strong focus on the role of early intervention as a preventative measure, along with protecting and promoting lifelong mental health and wellbeing through the critical exploration of evidence-based literature and research.

The programme has been designed to enhance the career development of a range of professions since graduates of the programme can expect to develop key skills and abilities, which are transferable to a number of professional domains involving child and adolescents. More specifically, the program helps prepare for, obtain, or maintain employment in fields involving children and adolescents. The postgraduate programme's approach is that children's and adolescents' mental health and well-being is influenced by developmental processes at numerous levels, from individual to socio-cultural and that approaches to working with mental health and well-being need to be informed by this dynamic and interactional system. The degree itself documents a student's high level of commitment to working with children and young people thus providing its graduates with an advancement in their professional career and the job market.
