**1.1** We would like to thank the Committee for advising us in more clearly expressing our mission and strategies. We totally agree that a clearly defined mission and strategy, is crucial and can ensure the sustainability of the Department.

The mission of the Department is to develop highly specialized professionals in respected sectors of the economy not only in Cyprus but also globally, by providing the contemporary knowledge and skills sought by companies and organizations. It also aims to bridge the academic knowledge with professional practice both from creative, as well as, environmentally oriented disciplines.

Strategically, the Department of Architecture, Land and Environmental Sciences is firmly committed to the planning of all its activities to enable the educational, research and other objectives that determine its academic profile, to be as effective as possible. These goals include, among others:

• The offer of quality and divertive curricula that meet the needs and requirements of the market, thus creating the conditions for a good professional career for graduates.

• Provision of interdisciplinary education and expertise.

• The development of its research activities, through the development of research programs and / or participation in research programs.

- Academic and research collaborations with other institutions, from Cyprus and abroad.
- Collaborations with local society, municipalities etc.

**1.2** We would like to thank the Committee for advising us in clearly highlighting the specificity of the Department of Architecture, Land and Environmental Sciences. Our response is the following:

This Department has a unique characteristic, especially in Cyprus, since it is constituted by programmes that belong both to creative as well as environmental disciplines. To this effect it contains the Programmes of Architecture, Digital Video Production (DVP) and Environmental



Impact Assessment and Sustainability Management (EIASM). Thus, its uniqueness lays in its emphasis both on creative thinking and environmental awareness.

Moreover, by the tautochronous presence and operation of different disciplines, the Department is specifically identified by a multifocal structure at four levels (Figure 1). At the level of the School, the level of the Department, the level of the Programme and the level of the Courses (modules).

In particular, at the level of the school we refer to the three different Departments (Architecture, Engineering, Real Estate). At the level of the Department we refer to the different programmes (i.e Architecture, Digital Video Production, Environmental Impact Assessment). At the level of the programme we refer to the different directions of the modules that compose the programmes.





In particular, at the level of the courses the multifocal approach is particularly reflected in the multiplicity and diversity of modules and teaching methods with which the students are faced. In particular, in the programme of Architecture, these consist of different stimuli, from different topics such as cinema, theatre, sculpture, music, photography, set design, literature, social sciences, philosophy, and mathematics. Indicative modules: (ARCHSR101 Space-Communication-Architecture), (ARCHSV306 Photography-Cinema-Set Design), (ARCHSR301 Object and Space), but also at the other end (REAL100 Principles of Real Estate and REAL302 Real Estate Development).

Beyond education, highly active participation and initiatives are left to, and actually practiced, by the students in all aspects of University life, processes, activities and events.

**1.3 Done.** This relationship is currently highly reinforced in the programme of Architecture by:

 Having dedicated modules, both theoretical and practical, that deal with these issues. In particular, in the Program of Architecture there exists in the 5<sup>th</sup> Semester a Studio Module (ARCHAS306) of 9 hours/week (10 ECTS) on the "Restoration and Reuse of historic buildings", supported by ARCHTH302 (5 ECTS) which is a Theory Course on the issues of "Theory of Conservation and Restoration". Furthermore, at the 8<sup>th</sup> Semester exists the Theory Course ARCHTH401 on "Architecture and Place".



- Incorporating in a considerable number of student projects, issues and problems directly related to these assets. This is represented in the recent publication of student projects <u>https://issuu.com/nup\_architecture/docs/theses\_11\_01\_redux</u>
- A characteristic example is also a final design thesis by one of our graduates that had as subject the "Staging of Hamlet at the archaeological site of the Tombs of the Kings" in Pafos.
- Pafos and the island of Cyprus are small territories, although with long past history, economic, social, cultural, at the crossroads of the Mediterranean, until today. This indeed is well understood by the Department, and is taken seriously into account both in formulating its Programmes, as well as in searching for an identity and a place in contemporary global situations.

## B. Conclusions and final remarks

The External Evaluation Committee wishes to thank the University and the Department for the documentation provided in advance of our visit. We also wish to thank all the staff and students we spoke to during our visit for the open engagement throughout all our meetings.

Overall, the EEC was satisfied that the Department mostly meets the quality assurance standards required. Although the department is small with enriched teaching staff and few students, they manage to have a strong bond between them that gives the opportunity for students to learn more.

Additional facilities and equipment we recommend will improve the students' knowledge and techniques but also and cooperation opportunities with other students from the department.

These suggestions will lead to improve the programme of study and the outcome quality of the students Learning.

The documentation supporting the Department has been well prepared and indicates a clear knowledge and consideration of the main aims and needs.

The weakest parts, for the EEC, are the faculty, which could be more robust with the insertion of expert visiting or permanent researchers, and that could be more international.

The publishing activity seems too limited and doesn't reflect a constant engagement in research. This activity could be also of great support in attracting students from abroad, in supporting the teaching activity, in developing the teaching staff careers and international relationship

## NUP comment:

We strongly believe that this final comment is in full <u>contradiction</u> with the EEC relevant comments in Chapter 5, whereby it's stated:

«The staff/student ratio of 1:7 and all staff is permanent. The educational background of all members is high, international, and versatile related to their studies for first and higher degrees. Choices on staff ensure complementarity in carrying out the programme of studies.

The staff/studio is excellent for a school of architecture. Staff is of international education background and complementary. The size of the school allows for good synergies between staff members and between staff and students»

Conclusively, we would like to thank the EEC for their invaluable comments and work provided both during the discussions held throughout the visit as well as within their evaluation report. We truly believe that their comments have helped us to strengthen and improve the profile of the Department of Architecture, Land and Environmental Sciences. Lastly, we wish to express that we are particularly pleased with the positive assessment in general and the valuable recommendations.
