

The Institution's development strategy and connecting with society

The long-term strategy of the PII is intricately intertwined with the challenges of the Middle East. The PII's five-year strategy is to offer programs in the fields of water, energy and food security, as well as an advanced management programs including data, entrepreneurship and technological innovation, and to create a hub that will deal with such major challenges of the reign. The Institute aspires be a catalyst for the broad and groundbreaking exchange of knowledge between people who have not met thus far and who, given the opportunity, can advance and implement and game-changing ideas together.

The EEC noted: "Links to society in Cyprus, Middle East and the 'Arab countries need to be explore further." (pg. 14).

To our understanding, the MBA program which focuses on entrepreneurship and innovation, and future programs in the field of water, energy, could have great appeal to students from Arab (Islamic) countries. We believe that particularly during a period of local and international religious and national tensions, the Pafos Innovation Institute could create a center of creativity and learning where people who strive towards progress and innovation can meet and engage in professional and personal dialogue.

Relationship with the Municipality of Pafos:

An agreement between the Municipally of Pafos and the PII was signed in September 2019. (The agreement is attached in Annex 1). As the agreement indicates, the campus and the buildings of the PII are owned by the Municipality of Pafos and the PII rents the them from the municipality, in a long-term lease of 15 years.

The municipality is not involved in financing the institute, only in efforts of marketing the program as sec. 8.1 indicates: "the parties undertake to collaborate in the effort to raise donation and financial support for the institutes and in the efforts of marketing its program in the reign.


3. Administration

7. Resources

The PII's funding program is based on a tuition of 15,000 EUR per student (in the parallel program at IDC the tuition is 25,000 \$). Based on this tuition and based on an estimation of 50 students for the MBA program, the total sum of 750,000 EUO, sustains the operation of the PII and scholarships to students as follows: The cost of the academic faculty, based on teaching hours is 345,000 EUR for the MBA program. Additional administrative expenses are 155,000 EUR per year. The total of 750,000 EUR, with the deduction of all operational expense create a surplus of 250,000 EUR for scholarships.

In addition, once the PII is formally accredited as a higher education institution and obtains accreditation for the MBA program, the PII will apply for international grants to support scholarships for students who will arrive, inter alia, from developed Arab countries. The PII will also market the program in order to raise donations to facilitate the implementation of its five-year strategy.

B. Conclusions and Final Remarks

As the program develops, the administrations and processes will be duly implemented, as the CYQAA requires.
