1. Remarks on the CYQAA Final Report

“The Council of the Cyprus Agency of Quality Assurance and Accreditation of Higher Education, during its 46th Summit on 30 September 2019, on the basis of Article 20 (2)(f) (i) of the “Quality Assurance and Accreditation in Higher Education and the Establishment and Operation -3- of an Agency on Related Matters Laws” of 2015 and 2016 [N.136 (I)/2015 and N.47 (I)/2016], and on the basis of the suggestions of the External Evaluation Committee and the comments of the institution on the report, decided that the programme is accredited to be delivered in Greek.

1. The program instructors should be constantly updated with specialized and experienced instructors both in the subject and distance learning teaching *(Το προσωπικό του προγράμματος πρέπει να αναβαθμίζεται συνεχώς με εξειδικευμένους και έμπειρους διδάσκοντες τόσο στο αντικείμενο όσο και στην εξ αποστάσεως διδασκαλία)*
2. Student – instructor interaction (regarding teaching material) should be constant and not only restricted during teleconferences *(Η αλληλεπίδραση των φοιτητών με τους/τις διδάσκοντες/ουσες, μεταξύ τους και με το υλικό πρέπει να είναι συνεχής και να μην περιορίζεται στις τηλεδιασκέψεις.)*

2. Institution's Response

The Institution informs the Agency on the two issues raised below:

1. The undergraduate program Byzantine Music – Psaltic Art is indeed a very specialised program, which consists of both a theoretical and a practical part. In order to ensure the quality of teaching and the collaboration with specialised and experienced instructors, the Department of Arts has advertised academic posts in all topic areas related to the programme's courses and needs such as: Music-Musicology-Theology-Liturgy-Music Therapy with specialisation in Byzantine Music-Psaltic Art. Moreover, the University ensures that all faculty involved in programs which are offered through E-Learning mode of instruction participate in the Faculty Professional Development Program, which evolves around three axes, namely the EUC Professional Development Program for newly-hired members of staff, the Ongoing Professional Development Program, as well as the EUC Professional Development Program on Innovative Interventions. These programs ensure that faculty are equipped with the necessary knowledge, skills, and teaching tools that relate to the specific methodologies and the educational and philosophical model of E-Learning.

2. Regarding the second issue raised, Byzantine Music–Psaltic Art is a program that requires a well-organized student-instructor interaction. This cannot be limited within the set number of teleconferences throughout each semester, but it is formulated around the specialised demands of the program's nature and the capacity of Blackboard, the University's learning management system. In order to meet the needs of the program's practical courses, a constant and continuous student-instructor interaction is set in place to ensure successful delivery, understanding and assimilation of the music material. The platform is used as a vehicle of educational material delivery – which in the case of this program consists not only of theoretical manuals but also of audio-visual recordings either by instructors aiming to aid self-guided study, either by students who send material for feedback. Synchronous-live feedback sessions are also set in place, in order to ensure that the chanting art is aurally transmitted and experienced. These sessions consist of one-to-one meetings, but also of group meetings (studio sessions) in order to increase interaction among students, promote continuous dialogue and exchange between students and instructors and enhance a sense of community among students of the program.
