The present document has been prepared within the framework of the authority and competencies of the Cyprus Agency of Quality Assurance and Accreditation in Higher Education, according to the provisions of the "Quality Assurance and Accreditation of Higher Education and the Establishment and Operation of an Agency on Related Matters Laws of 2015 and 2016" [N. 136 (I)/2015 and N. 47(I)/2016].

A. Introduction

The committee made an on-site visit to Cyprus on 8-10 May 2019. Prior to their visit, they received the Application for Evaluation for the Master Programme in the Didactics of French as a Foreign Language, and a copy of the Evaluation Report which they would be required to fill out. In Cyprus, they visited the University on Wednesday 8 May, where they met i) the Vice-Rector Eirini-Anna Diakidou, who briefed them on the broader institutional context, ii) members of the Department of French and European Studies who presented the programme; iii) the Acting Director of the Library; iv) colleagues who teach on the programme; v) students enrolled on the programme; vi) the Secretary of the Department. The committee also visited the Library and different spaces used by the Department in order to assess the resources available to support the programme.

1. Study programme and study programme's design and development (*ESG 1.1, 1.2, 1.8, 1.9*)

<u>Findings</u>

The programme is generally very well designed and corresponds well to international standards and norms. It has a clear focus relating to the teaching of French as a foreign language, and is designed to prepare students for a career in education both as a teacher and as a school director. It also has a research element that can prepare students for doctoral study.

<u>Strengths</u>

The Department is particularly to be commended for developing a Masters programme that succeeds regularly in recruiting such a good cohort of students. To sketch the international context: there are very few Masters of any kind in French Studies in non-Francophone countries that succeed in elaborating viable programmes of study at Masters level, largely as a result of the dramatic drop of interest in French as a second language in recent decades. In addition, the specific situation in Cyprus has clearly been exacerbated by the sharp drop in staff numbers in the Department - from eleven to five - over the last few years because of the economic crisis. The Department has shown laudable flexibility and inventiveness in meeting these challenges by drawing on resources in the Departments of Education and Psychology to construct a pathway of courses dealing with educational issues of relevance to the programme's emphasis on pedagogical issues. It thus manages to offer a satisfactory range of optional courses alongside its core offering of courses relating to French and, in the process, has developed a programme with a distinctive and original focus.

Another strength of the programme is that it draws on the impressive research record of colleagues in the Department of French and European Studies. Staff members have continued to publish extensively and to maintain research links with colleagues in other countries, notably in France, notwithstanding the adverse effects of the economic crisis.

The programme also benefits from the Erasmus agreements with a number of other countries, which makes a key contribution to broadening students' horizons and developing their intercultural awareness.

We have identified a number of areas of improvement as follows:

1.3.5: While students provide feedback on current course provision through the evaluations they complete at the end of each course, we saw no evidence of staff-student consultative committees.

1.5.2: More attention should be paid to the methodology of research specifically at postgraduate level. While there are research methods courses available at undergraduate level, it would be good to introduce such a course as an integral part of the Masters programme.

1.5.6 and 1.5.7: While the vocational nature of the course is valuable, care must be taken to ensure that the theoretical dimension of the programme is not overly subordinated to the practical.

1.8: The use of more recent bibliographical references could be more visible in the course outlines and documentation.

1.9: It is not explicit in the documents but given the high level of research activity of the teaching staff and their frequent participation in international collaborations, the research-led aspect of the programme's teaching could be more visible.

2. Teaching, learning and student assessment (ESG 1.3)

- The process of teaching and learning supports students' individual and social development and respects their needs.
- The process of teaching and learning is flexible, considers different modes of delivery, where appropriate, uses a variety of pedagogical methods and facilitates the achievement of planned learning outcomes.
- Students are encouraged to take an active role in creating the learning process.
- The implementation of student-centered learning and teaching encourages a sense of autonomy in the learner, while ensuring adequate guidance and support from the teacher.
- Teaching methods, tools and material used in teaching are modern, effective, support the use of modern educational technologies and are regularly updated.





- Practical and theoretical studies are interconnected.
- The organisation and the content of practical training, if applicable, support achievement of planned learning outcomes and meet the needs of the stakeholders.
- Mutual respect within the learner-teacher relationship is promoted.
- Assessment is appropriate, transparent, objective and supports the development of the learner.
- The criteria for and method of assessment, as well as criteria for marking, are published in advance.
- Assessment allows students to demonstrate the extent to which the intended learning outcomes have been achieved. Students are given feedback, which, if necessary, is linked to advice on the learning process.
- Assessment, where possible, is carried out by more than one examiner.

<u>Findings</u>

Teaching and assessment methods are wholly consistent with the programme's aims and objectives. Students are encouraged to participate actively in the learning process and systems are in place to monitor their progress. Facilities are appropriate to deliver the course's aims.

Strengths

Small-group teaching enables a very good level of contact between staff and students.

2.9.: While the new library is a magnificent asset, its holdings in French areas of inquiry could be improved; in particular, subscriptions to key journals in French language and teaching (such as *Langue française, Langages, Journal of French Language Studies,* as reported in our meeting with teaching staff) should be obtained. This would facilitate updating of bibliographies in line with our comments in the previous section.

2.12: See comments for 1.5.2, 1.5.6 and 1.5.7 about the relative weights of practice and theory in the programme. One way to enhance the students' research skills could be to organise a forum in which they could present and discuss issues relating to the elaboration of their 'travail de fin d'études', whether a dissertation or a report on their internship.

3. Teaching Staff (ESG 1.5)

<u>Standards</u>

- Fair, transparent and clear processes for the recruitment and development of the teaching staff are set up.
- Teaching staff qualifications are adequate to achieve the objectives and planned learning outcomes of the study programme, and to ensure quality and sustainability of the teaching and learning.
- The teaching staff collaborate in the fields of teaching and research within the HEI and with partners outside (practitioners in their fields, employers, and staff members at other HEIs in Cyprus or abroad).
- Recognised visiting teaching staff participates in teaching the study programme.
- The teaching staff is regularly engaged in professional and teaching-skills training and development.
- Assessment of the teaching staff takes into account the quality of their teaching, their research activity, the development of their teaching skills and their mobility.

<u>Findings</u>

Academic staff on the programme have the necessary expertise to deliver the teaching in an appropriate manner, informed by their research specialisations. All of them manage to maintain an impressive level of research activity alongside a full teaching load. The reduction in numbers of staff has not to date damaged the quality of the programmes delivered, although current numbers are not sustainable in the long term.

<u>Strengths</u>

The staff are highly committed to the Department and manifestly act very well together as a team. The ability to attract Visiting Professors to the Department is impressive, demonstrating that the Department has an excellent reputation as a place to work.

Areas of improvement and recommendations

There appear to be no policies in place at institutional level to take account of underrepresentation of staff in terms of gender, race, LGBTQ issues, etc. This is of particular





importance in a discipline such as French Studies, where the proportion of women at senior levels of staff is usually far lower than at junior levels. Many universities have adopted policies (such as the Athena Swan programmes now widespread in the UK, Australia, Ireland, etc.) which aim to redress gender inequities in higher education, and we recommend strongly that the University of Cyprus follow what is now recognised internationally as accepted best practice in this area.

3.1: The sharp drop in the number of full-time permanent members of the Department over the last few years constitutes a risk to the sustainability of the programme. While two recent / ongoing appointments will partly remedy this, the difficulties of providing a full Masters syllabus in addition to undergraduate provision suggest further recruitment will be necessary.

4. Students (ESG 1.4, 1.6, 1.7)

- Pre-defined and published regulations regarding student admission, progression, recognition and certification are in place.
- Access policies, admission processes and criteria are implemented consistently and in a transparent manner.
- Information on students, like key performance indicators, profile of the student population, student progression, success and drop-out rates, students' satisfaction with their programmes, learning resources and student support available, career paths of graduates, is collected, monitored and analysed.
- Fair recognition of higher education qualifications, periods of study and prior learning, including the recognition of non-formal and informal learning, are





essential components for ensuring the students' progress in their studies, while promoting mobility.

- Students receive certification explaining the qualification gained, including achieved learning outcomes and the context, level, content and status of the studies that were pursued and successfully completed.
- Student support is provided covering the needs of a diverse student population (such as mature, part-time, employed and international students, as well as students with disabilities).
- A formal procedure for student appeals is in place.
- Students are involved in evaluating the teaching staff.
- Students' mobility is encouraged and supported.

<u>Findings</u>

Procedures for admitting students to the programme and supporting them in difficulties they may face are well established and appear to function satisfactorily. The structure of the programme, that enables students to complete their course of study in up to eight semesters, allows for a relatively high degree of flexibility which may be of value in protecting students against the increasing stresses of academic study.

<u>Strengths</u>

Support for students who are suffering from mental health problems seems particularly strong. Financial support for students in the form of scholarships appears to be strong.

5. Resources (ESG 1.6)

- Adequate and readily accessible resources (teaching and learning environments, teaching materials, teaching aids and equipment, financial, physical and human support resources*) are provided to students and support the achievement of objectives in the study programme.
 - * Physical resources: premises, libraries, study facilities, IT infrastructure, etc. Human support resources: tutors/mentors, counsellors, other advisers, qualified administrative staff
- Adequacy of resources is ensured for changing circumstances (change in student numbers, etc.).





- All resources are fit for purpose and students are informed about the services available to them.
- Teaching staff is involved in the management of financial resources regarding the programme of study.

<u>Findings</u>

The Department is benefiting directly from the University of Cyprus's recent investment in the new campus with its library and faculty buildings. Colleagues would welcome similar investment in central administrative services, such as IT provision and research support services.

<u>Strengths</u>

The new library offers students flexible and up-to-date space and resources that are comparable to those in the most prestigious institutions. The generous individual research allowance is clearly invaluable for colleagues in maintaining a high level of international research collaboration and mitigates the disadvantages of Cyprus's geographical situation.

recapitulation, the programme succeeds impressively in offering a viable and focussed Masters, which is a very real achievement in the light of the drastic fall in student interest in studying French as a foreign language. It has an ambitious and targeted curriculum that supplements its core of courses specific to the teaching of French with a range of optional courses relating to topical issues in education provided in other Departments. It thus succeeds in offering a French-specific course, notwithstanding the sharp reduction in staff numbers since the economic crisis. The teaching staff has advanced expertise appropriate to the subject content, and the staff-student ratio of the classes taught corresponds well to international recommendations. Nearly all students benefit from a scholarship and the processes for monitoring student admission and progress are all appropriate. A particularly strong point of the programme is the involvement of Erasmus students, and the presence of Visiting Professors in the Department.

Areas in which there remains room for improvement include the introduction, at institutional level, of staff-student consultative committees. The introduction of methodological training specific to the needs of students at post-graduate level would also represent an improvement.
