The evaluation Committee consisted of 3 academics and a student representative who visited the premises of the Cyprus University of Technology. After a briefing by the Rector of the University and Dean for Financial Affairs, the Committee received a detailed presentation on the proposed program by the Program Coordinator and Dean of the Department. This was followed by meetings with teaching and administrative staff. The Committee also had an opportunity to meet and discuss student matters with representatives. In addition, the evaluation committee toured the facilities and experienced first-hand the learning environment and services provided.

The committee would like to thank colleagues at Cyprus University of Technology for providing all the requested documentation and evidence for the purpose of conducting this evaluation and preparing this report.

1. EFFECTIVENESS OF TEACHING WORK – AVAILABLE RESOURCES

- **Organization of Teaching Work**
- **Teaching**
- **Teaching personnel**

The new UG program to be offered is a conventional academic 4 years Bachelor in "Integrated Marketing Communication" with two specialization pathways as follows:

- a) Advertising, Public Relations and Impression Communication, or
- b) Perception Management and Political Communication

The program includes both compulsory and elective modules. During the 3rd year of study, students can choose from the offered electives as per their selected pathway. An optional thesis and a compulsory internship complement the overall program of study. The specific program has been informed by an extensive market research with regards to the industry needs (indicative sources include Authority for Human Resource Development of Cyprus, Forecasting Study for the Needs of Employment in Business Market and Sectors) as well as other similar academic programs offered in various HE institutions in Europe and the USA. Necessary information regarding the effective delivery of the academic program is provided timely to students (publication of academic calendar and program curricula, updated module web pages (Moodle)).

Teaching is delivered by permanent academic staff complemented with visiting and adjunct professors based on the various teaching needs. The Department is in a process of hiring new academic staff in tenure track positions to further support the teaching program.

The methods of teaching are appropriate (lectures and seminars using a variety of teaching tools such as business case studies, audiovisual material, tutorials etc). The VLE (Moodle) is appropriately used and updated with necessary teaching material for the students. There is a centralised assessment policy that includes mid-term evaluation, participation and final exams applied throughout the teaching units. Although this centralised pattern creates a unified approach across the program, it would be preferable that more flexibility in the assessment strategy would allow a more nuanced evaluation of students' skills according to each module's idiosyncrasy.

The committee was pleased to see the enthusiastic attitude of the teaching and supporting academic staff. Based on the committee's discussion with some members of the academic staff and the assessment of the academic CVs (all existing academic staff), the teaching team is well-equipped with the appropriate

credentials to effectively deliver the allocated modules. However, the committee expressed its concerns regarding the recruitment of sufficient and appropriate academic personnel for the successful operation of the program of study. The Committee considers such recruitment essential for the delivery of the program. The Committee was reassured of the Department's and University's intentions to proceed with hiring the necessary academic staff. The Department informed the Committee that the specific positions have already been advertised (4 permanent and one STS) with specifications tailored to the needs of the modules and the program overall. The process is expected to be finalised by February 2019.

The Committee was pleased to see that the program team has conducted extensive research and took into consideration the latest thinking and trends in the field of integrated communications, when it came to the design the program. However, the "integrated" aspect could have been more evident in the overall program structure. Specifically, the Committee believes that the module and knowledge is not progressing from semester to semester. Clearer links among modules would have made it possible for students to develop their knowledge and competencies in a more streamlined manner. This may have been partly due to the large number of potential electives that could dilute the coherency of the program objectives.

Instead, the Committee would suggest that program team considers the following:

- 1) Review the content of the proposed new modules and ensure that they are appropriately developed for the level that they are offered. Ideally, the program team can also consider the overall assessment strategy of the program while reviewing the content of the new modules.
- 2) Reconsider the modules offered per semester to ensure the logical progression of knowledge as expected by the program overall learning objectives and its mission to provide an "integrated" program. Otherwise, the program is a "collection of modules", as opposed to a coherent attempt to provide a truly integrated communications program.
- 3) The Department should ensure that compulsory and electives modules do not overlap significantly with similar modules offered by the School and/or across the University.
- 4) The 1st and 2nd years of the program should encompass general foundations and principles of communication modules that will provide the basic understanding of the field. Then, in the 3rd and 4th years, students will select their pathway of choice and self-customize the program with specific to the pathway modules.
- 5) Reduce the number of electives to those that are the most relevant to each pathway. This could potentially be undertaken by grouping the electives and

only giving students a choice between two groups of electives (based on the selected pathway) as opposed to picking numerous individual modules. Such an approach will help streamline the operations of the program, rationalize the allocations of resources, simplify planning and ensure a coherent learning journey.

- 6) Considering that this is an undergraduate program in integrated marketing communications, the Department could consider merging the multiple research methods modules (quantitative, qualitative and content analysis) into one module that covers all the basic areas of research for business students.

Overall, the Committee is satisfied with the management of the program. The team has sufficient experience in running similar programs. The Committee feels confident that the program team can undertake the necessary improvements to address the suggestions made above (1-6) before the program can be implemented. The Committee would like to note the team's enthusiasm (especially Prof Panigyrakis and Evi Kyriakou) for the proposed program and how it can help underpin the future development of the Department and similar postgraduate/doctoral programs.

The under-consideration program has been informed by an extensive market research with regards to the industry needs and the economic demands of the local market. This should ensure that the program has clear employability potentials and that students can be absorbed easily after graduation. The Department has extensive links with Universities of high standing in Europe and in the USA. Such collaborations can inform the program development and provide learning and teaching opportunities for both staff and students.

3. RESEARCH WORK AND SYNERGIES WITH TEACHING

- Research Teaching Synergies

The majority of staff members of the teaching team hold PhDs in their respective fields. They are research active, attend international conferences, publish papers--often in highly regarded academic outlets--that are relevant to the program under consideration. Despite that the University has only been recently established, it has managed to attract significant research outcome and establish collaborations with renowned European and International bodies. This enhances the research environment and encourages staff to be active members of this research culture. The Committee has identified that there are sufficient facilities and equipment to provide support to the research component of the program.

Cyprus University of Technology is supportive of such activities and offers opportunities and tangible incentives for further research development. A generous research account can be used to fund attendance at conferences or support other research-related activities (e.g. data collection or research internships). Also, the University encourages interdepartmental collaborations both when it comes to research, but also to teaching which can be beneficial to this program (reflected on the options made available by the other Departments).

The external evaluation committee identified that the learning staff acknowledges the importance and value of research led teaching. This was reflected, for instance, in

that peer-reviewed journal articles are used as part of the learning process inviting students to critically reflect on them.

4. ADMINISTRATION SERVICES, STUDENT WELFARE AND SUPPORT OF TEACHING WORK

It is evident that the Cyprus University of Technology recognises the need to support students, especially those facing learning and physical challenges and therefore they have put in place administrative mechanisms to support them. Similar administrative mechanisms were found to be in place when it came to the monitoring of student progression more broadly so that students can be supported proactively. Administrative services included among others student well-fare, career development, counselling and general advising. The staff and student handbooks provided a clear outline of the administrative processes and mechanisms that are in place.

The evaluation Committee visited the library and found it to be well-organised. The library offered suitable books and online resources (such as access to databases) that could well-support the program. It also featured a number of working spaces and a friendly atmosphere. The information communication and technology (ICT) services provided Internet access throughout the campus buildings, while computer labs were well-equipped with up-to-date software and hardware. The Committee was particularly impressed by the laboratory and teaching equipment related to the production of audio-visual content.

Academic registrar and student operations are available to maintain student records and to provide support for the smooth operation of the program and the University more broadly. The financial planning based on the number of students expected (40 in the first instance) appears to be reasonable. There is a number of posts in the process of recruitment which will help support the delivery of the program. The Committee expressed concerns with regards to the insufficient staffing of the Department as it stands with regards to the timely appointment of tenured staff. The University Senate has reassured the Committee of its intentions to fill these positions as quickly and as efficiently as possible. If there are any complications in filling the vacancies with tenured academic staff, visiting staff will be appointed and the required financial resources have already been secured.

CONCLUSIONS AND SUGGESTIONS OF THE EXTERNAL EVALUATION COMMITTEE¹

- The present situation of the program, good practices, weaknesses that have been detected during the external evaluation procedure by the external evaluation committee, suggestions for improvement.

The Committee believes that the proposed program can be of the required standards, after a substantial restructuring of modules and content has been undertaken. It features a wide range of modules and pathways that should cater for student interests, offering a novel approach to communication studies. Staff are enthusiastic about creating a learning environment that enhances student experience. The Cyprus University of Technology is equipped with the appropriate infrastructure and financial resources to deliver the proposed program.
