This Final Report was prepared on the basis of Article (20) (2)(f) (i) of the "Quality Assurance and Accreditation in Higher Education and the Establishment and Operation of an Agency on Related Matters Laws" of 2015 and 2019 N. [136 (I)/2015 to N.47(I)/ 2019]».

THE PROCEDURE:

On 28 June 2019 the legal representative of the Higher Education Institution **European University** submitted an application (Doc. 200.1), based on Article (17) of the "Quality Assurance and Accreditation in Higher Education and the Establishment and Operation of an Agency on Related Matters Laws" of 2015 and 2019, for the evaluation-accreditation of the program of study:

IN ENGLISH: Music: Music Education, Performance, Composition (1,5 years, 90 ECTS, Master of Music)

This application is registered in the file with the reference number: 07.14.327.054

In the framework of competences conferred on it by the relevant legislation, the Council of the Agency has constituted an External Evaluation Committee (EEC) which, after initially examining the institution's application for program evaluation and accreditation, performed an on-site visit at the institution on **10-11 February 2020**.

The EEC met with the head of the institution, the head of the relevant department, the program's coordinator, members of the academic staff, members of the administrative staff, students and/ or their representatives and the Internal Quality Assurance Committee.



Additionally, the EEC examined the institution's facilities (library, computer labs, research infrastructures, etc.), various documents presented and/or requested by the EEC, the School's/ Faculty's structure and the program's position in it, the CVs of the teaching staff and their relationship to the institution as teachers in regard to any other duties and teaching in other programs of study.

The EEC has documented its findings and recommendations and drew up the External Evaluation Report in the Doc. 300.1.1.

CYQAA Council's Decision

The Council of the Cyprus Agency of Quality Assurance and Accreditation of Higher Education, during its 53^{rd} Summit on 12^{th} May 2020 on the basis of Article 20 (2)(f)(i) of the "Quality Assurance and Accreditation in Higher Education and the Establishment and Operation of an Agency on Related Matters Laws" of 2015 and 2019 [N. 136 (I) / 2015 and N.47 (I) / 2019], and on the basis of the suggestions of the External Evaluation, the comments of the institution on the report and the Feedback Report, decided that the program is accredited to be delivered in **Greek and English with the following specializations:**

- Music Education
- Compositon
- Performance

The Agency requires the Institution no later than 31 December 2020 to:

- attract performers who focus on research-led performance, and who will work closely with the full-time faculty to ensure the coherence of the performance concentration.
- Review all aspects of instrumental provision and acquire quality instruments to conform to international standards.
- Acquire further online databases: RILM, JStor, RISM, MGG, to accompany Proquest, the Naxos Music Library, Groveonline and other existing resources.

In addition, the Agency require the Institution to attract Visiting Faculty who will be engaged with teaching through an entire semester in order for the programme to become more visible internationally, and will give the opportunity to its students to broaden their horizons and knowledge.

The current accreditation begins in the **Winter** semester of the academic year **2020 – 2021** and ceases to be in effect at the end of the **Spring** semester of the academic year **2024 – 2025**.

On the basis of Article (4) of the relevant Legislation, it is noted that "the above accreditation is valid for the period provided by the provisions of the Law and is repeated every five (5) years and that the procedure starts at the request of the institution which must, and shall be submitted at least sixteen (16) months before the expiry of the previous accreditation".
